1. Maine Historical Society (The Society) will not grant exclusive rights to the use of its collections to any party or parties, and it assumes no responsibility for claims arising from third parties. The Society reserves the right to use its own material and retains any and all rights.
2. All permission is for one-time use only. All additional and subsequent use must receive written permission from Maine Historical Society. This includes all current and future forms of media.
3. A publication fee will be set by The Society based upon use and duration of use. The fee is due when permission is granted and before publication. The fees cover one-time, non-exclusive use per each item. Publication fees are additional to any expense levied as a result of copywork, and purchase of copies does not guarantee permission to use.

4. Display, posting on a web site, video, CD-Rom, TV and advertising are all forms of publication, and permission must be granted before material is used. The applicant will provide The Society with a detailed description of planned use.

6. Applicant shall give to The Society one copy of the publication in which the illustrative material appears.
7. Responsibility for observance of copyright and other publications rights, including literary rights, rests with the patron and not with The Society.
8. If an image is cropped in any way, the caption must include the word “detail.” Nothing may be superimposed over the image without prior permission. The content of the material may not be altered.
9. Use may not be sold or transferred. The user is responsible for observance of these conditions and all copyright laws.
10. The courts of the state of Maine shall decide any conflicts arising from this contract.
11. Maine Historical Society reserves the right to void this contract if the applicant and publisher do not follow these conditions.
